D. GENERAL INFORMATION AND TOUR CONDITIONS:

Price: The price of the packages are subject to Standard Terms and Conditions and exchange rates at time of final payment.

Deposit: A deposit of R20 00,00 PER PERSON is payable on booking and is not refundable. A final statement will be e-mailed to you during the 2nd week of December 2011 and is payable on presentation. Interest at Prime +1% will be charged on amounts not settled within 7 days of statement. Cancellations received after issue of statement will still be liable for the full tour package amount and we advise clients to take out travel insurance with cancellation cover (see below). If the booking is made after 15 December 2011 the full package contract price is to be paid at the time of booking.

Itinerary: The package is subject to weather and technical influences.

Passport, Visas & Health requirements: We provide basic advice to passengers regarding visa requirements for the USA.

Liabilities: The Golf Travel Company and/or their agents, in making arrangements for air and land services, act as agents only and on condition that they shall not be liable for any injury, death, damage, loss, accidental delay or irregularity that may be occasioned by any defect in any vehicle or form of conveyance or mishap at any place of accommodation, or for any reason whatsoever.

Insurance: All passengers will be required to have insurance for injury, death, accident and medical expenses in order to obtain a visa. Insurance for enforced pre-tour cancellation should be arranged and is recommended as the tour operator will not be liable for any claims whatsoever.

Changes to bookings: An amendment fee of R300,00 will be charged for any changes made to the packaged itinerary.

Cancellations and Refunds: No refund can be made for visits, sightseeing, meals, transfers, accommodation, golf or other services included in the tour price which were not utilized. Should the customer wish to cancel for whatever reason, The Golf Travel Company must be advised in writing under the signature of the customer. Cancellations received after the issue of the statement on 15 December 2011 will result in a 100% cancellation fee. Travel insurance with a cancellation clause is therefore strongly recommended.

Golf cars: The Golf Travel Company will pre-book golf cars but cannot accept responsibility for availability on the day for weather reasons.

Acceptance: The payment of the deposit by you will be deemed to be your acceptance of these tour conditions.
