**GENERAL INFORMATION AND TOUR CONDITIONS:**

**Price:**  
The price of the tour is subject to Standard Terms and Conditions, exchange rates and airfares at time of final payment. The price of the package is based on a minimum of 40 passengers and a reduction in this number may lead to a price adjustment for the tour package.

**Deposit:**  
A deposit of R3300,00 PER PERSON is payable on booking and is not refundable unless in the case of the cancellation of the tour by the tour operators (see insurance below). A final account will be forwarded to you 8 weeks prior to departure and is payable on presentation. Interest at Prime +1% will be charged on amounts not settled within 7 days of invoice. If the booking is made 6 weeks or less before said departure date, the full contract price is to be paid at the time of booking.

**Itinerary:**  
The itinerary details are subject to airline timetable changes, as well as weather and technical influences.

**Passport, Visas & Health requirements:**  
We provide basic advice to South African passport holders regarding visa requirements. Clients travelling on a passport of a different nationality should check with their embassy or consulate and must make sure they have all the necessary valid travel and health documents to comply with the requirement of the country they are visiting or travelling through.

**Liabilities:**  
The Golf Travel Company and/or their agents, in making arrangements for air and land services, act as agents only and on condition that they shall not be liable for any injury, death, damage, loss, accidental delay or irregularity that may be occasioned by any defect in any vehicle or form of conveyance or mishap at any place of accommodation, or for any reason whatsoever.

**Insurance:**  
All passengers will be required to have insurance for injury, death, accident and medical expenses. Insurance for enforced pre-tour cancellation (medical) should be arranged and is recommended as the tour operator will not be liable for any claims whatsoever.

**Changes to bookings:**  
An amendment fee of R300,00 will be charged for any changes made to the packaged itinerary. This charge will be applicable to any changes made to the homeward flight dates, but will not be charged when booking published optional extensions. In the event of a change being made to your basic tour flight arrangements, an additional fee will be charged by the operating airline. Please consult our office for this additional charge.

**Cancellations and Refunds:**  
No refund can be made for visits, sightseeing, meals, transfers, accommodation, golf or other services included in the tour price which were not utilized. Should the customer wish to cancel for whatever reason, The Golf Travel Company must be advised in writing under the signature of the customer. Cancellations received within 6 weeks prior to departure will result in 100% cancellation fee.

**Medical Certificate:**  
A doctor's certificate confirming good health will be required for passengers 65 years and older.

**Excess Baggage Charges:**  
Please note that where possible The Golf Travel Company endeavour to book with airlines that carries golf bags free of charge. However on some routings we are unable to use those airlines and the then operating airline will charge excess on golf bags at check in.

**Golf cars:** The Golf Travel Company will pre-book golf cars when requested to do so by clients but cannot accept responsibility for availability on the day.

**Acceptance:**  
The payment of the deposit by you will be deemed to be your acceptance of these tour conditions.
